The Fund has delegated to RA Capital the sole power to vote and the sole power to dispose of all securities held in the Fund's portfolios, including the shares of the Issuer's Common Stock reported herein. Because the Fund has divested itself of voting and investment power over the reported securities it holds and may not revoke that delegation on less than 61 days' notice, the Fund disclaims beneficial ownership of the securities it holds for purposes of Section 13(d) of the Act and therefore disclaim any obligation to report ownership of the reported securities under Section 13(d) of the Act and therefore disclaim any obligation to report ownership of section 13(d) of the Act, of any securities of the Issuer beneficially owned by RA Capital.
